## Skagit Valley Giant Pumpkin Festival 2017 Giant Fruit & Vegetable Weigh-Off Entry Form

### Contest Rules:

1. All cabbages entered in the show must be a Brassica oleraceae (capitata group) and entries must be grown by participant.
2. The winning cabbage is judged by weight alone. Cabbages must be in good physical condition to qualify and will be rejected if split open or disfigured.
3. No extra weight or foreign objects may be added to the cabbage. The judges reserve the right to inspect or probe any cabbage to determine it is in good physical condition and that no foreign objects have been introduced. Submission to inspection is a condition of eligibility.
4. Cabbages may be entered with all attached wrapper leaves. Only leaves that fall off after the cabbage is received by officials may be weighed. Roots must be trimmed to within two inches of the leaves. Cabbages must be free from water, slugs and excessive dirt.
5. Competitors must be on-site 30 minutes before weigh-off (weigh-off begins at noon) and must be present during the weighing of their entry.
6. No entrant or spectator shall attempt to influence the judges or impede the proceeding of fair competition. The judge's decision is final.
7. All pumpkin entries will be required to remain at Christianson's Nursery & Greenhouse for the duration of the weigh-off until prizes are awarded..
8. Prizes will be awarded at 3pm on Saturday, September 30. Must be present to win!
9. Only one competition pumpkin per grower. Extras are weighed and called "Exhibition" and cannot be considered for prizes.

**Failure to comply with these rules and regulations will deem participants ineligible to compete.**

- no responsibility for damage to the pumpkins while on site
- no responsibility for personal injury before, during, and after the competition
- no liability for damage to equipment before, during, and after the weigh-off
