

## *Christianson's 6<sup>th</sup> Annual Mid-Summer Antique Fair 2019*

### *Exhibitor Agreement*

1. Spaces are reserved and guaranteed on a first come first served basis. Spaces will be reserved by payment. 10' x 10' spaces are standard, and the fee scale is according to location: 1888 Schoolhouse \$125 (SH-3 spaces available); Big Tent \$100 (BT-8 spaces available); Open Lawn space \$75 (LA - 6 spaces available).
2. North Meadow Field \$50 per space: 26 spaces of 15' x 15' spaces for tent, car or truck; 8 spaces for vintage trailers, buses or food trucks; 6 spaces of 15' x 15' tent under The Vinery eaves. Vendors are required to bring your own WHITE pop-up tent (not to exceed 15' x 15') for lawn spaces. Payment in full is required to reserve a space. 3. Set up for vendors: Thursday, August 8, 9 a.m. – 4 p.m., and Friday, August 9, 9 am – 4 pm.

#### **SET UP IS FOR VENDORS ONLY...CLOSED TO THE PUBLIC**

4. *To cancel a pre-paid reservation, you must call on or before the Monday prior to the show.* All cancellations are subject to a \$10 administrative fee. There is a \$25 service fee for returned checks. Christianson's Nursery reserves the right to change any assigned space of exhibitor and relocate for a REASONABLE cause at their sole discretion.
5. All merchandise must **fall in the category of antique, antique collectible, vintage, or upcycled**, and all are subject to Christianson's Nursery approval. *A small percentage (no more than 10%) of hand-made merchandise will be allowed if it compliments antiques and is approved by Christianson's Nursery.*
6. Christianson's Nursery reserves the right to cancel a booth reservation or require alteration of *any merchandise or activity that is inconsistent with the quality, theme, or image of the show.*
7. Exhibitors are allowed to back vehicles into loading area near the Schoolhouse and North Meadow Field. No vehicles will be allowed on the Schoolhouse lawn. Exhibitor parking will be provided. Vintage trailers, cars and trucks will be assigned spaces and will be directed how to park. Staying overnight in your trailers during set up is acceptable for Exhibitors only. We do not provide electricity or water hookups. Restrooms are available for your convenience. Exhibitors must bring own hand trucks and dollies and help to unload, set up and take down.
8. Dealer's badges are provided and must be worn by all exhibitors on Friday and Saturday.
9. Christianson's Nursery is entitled to re-sell spaces not claimed by noon on Friday, August 9, and payments will be forfeited without prior notification.

10. Exhibitor must keep exhibit open during all show hours. **THERE WILL BE NO EARLY PACKING DURING SHOW HOURS.** Show hours are from 5 p.m. to 8 p.m., Friday, August 9 and 9 a.m. to 4 p.m., Saturday, August 10, 2019. Dealers are responsible for removing merchandise by the end of the show day unless arrangements have been made in advance.
11. Exhibitor must keep their exhibit within the designated boundaries of their rented booth and avoid interference with other booth/exhibitors.
12. Exhibitor must provide own chairs, displays and wracks. It is preferable that exhibitor provide own tables, although tables are available for rent. **Hanging product directly on the interior Schoolhouse walls is strictly prohibited.**
13. Exhibitors must duly report all sales made during the show in accordance with the appropriate sales tax regulations and abide by all pertinent city, county, state and federal laws, ordinances, fire and safety codes, and all pertinent regulations of the show site.
14. Nightly security is provided. **CHRISTIANSON'S NURSERY IS NOT RESPONSIBLE OR LIABLE FOR THE LOSS OR DAMAGE TO EXHIBITOR'S PROPERTY FROM THEFT, MYSTERIOUS DISAPPEARANCES, OR DAMAGES BY FIRE, WATER, ACCIDENT, OR ANY OTHER CAUSE.**
15. Exhibitors at the Schoolhouse will have access to modest amounts of electricity but must bring their own surge protector and extension cords.
16. Exhibitor is responsible for the payment of any damage charges assessed by Christianson's Nursery for accidental damage caused by exhibitor or failure to observe the rules and regulations for the construction and operation of his/her booth.
17. Pets of any kind are prohibited except for service animals.
18. Christianson's Nursery is not liable for acts of Nature which may result in the cancellation, rescheduling, or modification of the event. The lease agreement shall terminate and the exhibitor waives any claim for damages except the return of the rental fee.
19. Exhibitor may not sublet or donate part or all of his/her booth space without the prior written consent of Christianson's Nursery.
